

**JAMA SOFTWARE  
CLOUD SERVICES EVALUATION LICENSE AGREEMENT**

BY COMPLETING THE ONLINE REGISTRATION FORM AND CLICKING THE “I AGREE” BUTTON, YOU SUBMIT TO JAMA SOFTWARE, INC., A DELAWARE CORPORATION (“WE” OR ”JAMA”), AN OFFER TO OBTAIN THE RIGHT TO ACCESS AND USE THE SOFTWARE (AS DEFINED BELOW) UNDER THE PROVISIONS OF THIS EVALUATION LICENSE AGREEMENT (THE “AGREEMENT”).

BY CLICKING THE “I AGREE” BUTTON, YOU HEREBY AGREE THAT YOU HAVE THE REQUISITE AUTHORITY, POWER AND RIGHT TO FULLY BIND THE PERSON AND/OR ENTITIES (COLLECTIVELY, THE “EVALUATOR”) WISHING TO ACCESS AND USE THE SOFTWARE WHICH WE PROVIDE TO EVALUATOR SOLELY FOR EVALUATION PURPOSES. IF YOU DO NOT HAVE THE AUTHORITY TO BIND THE EVALUATOR OR YOU OR THE EVALUATOR DO NOT AGREE TO ANY OF THE TERMS BELOW, JAMA IS UNWILLING TO PROVIDE ACCESS TO THE SOFTWARE TO THE EVALUATOR, AND YOU SHOULD NOT CLICK THE ACCEPT BUTTON AND SHOULD DISCONTINUE THE REGISTRATION PROCESS.

**1. Software:** The “Software” includes any software and documentation owned, hosted, made available and/or distributed by Jama under this Agreement. Other than the license granted herein, Jama retains all rights in and to the Software. Consistent with 48 C.F.R. 12.212 and 48 C.F.R. 227.7202-1 through 227.7202-4 (JUNE 1995), the Software is provided to U.S. Government End Users (i) only as a commercial end item and (ii) with only those rights as are granted to all other end users pursuant to the terms and conditions herein.

**2. Grant of License:** Unless terminated earlier pursuant to Section 6 below, Jama grants to Evaluator for a thirty (30) day period (the “Evaluation Period”), a nontransferable, nonexclusive, limited license to access and use the Software as made available via Jama’s third party hosting services (“Hosting Services”) for the sole purpose of internal evaluation and testing for suitability for purchase by Evaluator only. Any extension of the Evaluation Period offered by Jama, in its sole discretion, shall be subject to the terms of this Agreement. Title to the Software shall remain with Jama at all times.

**3. Exclusions:** Evaluator shall not: (i) download or copy any part of the Software; (ii) reverse compile, reverse assemble or otherwise attempt to obtain the source code of any portion of the Software; (iii) distribute, disclose, market, rent, lease, or transfer the Software or act as a service bureau with respect to the Software; (iv) export the Software; (v) disclose benchmarks or other comparisons of the Software without Jama's prior written consent; (vi) disclose any confidential information provided by Jama; (vii) modify or make derivative works of the Software;(viii) allow others to make or obtain copies of the Software; (ix) in any way access, use, or copy any portion of the Software code (including the logic and/or architecture thereof and any trade secrets included therein) to directly or indirectly develop, promote, distribute, sell or support any product or service that is competitive with the Software, , monitor availability of the Software or Hosting Service, or identify or exploit any defect within the Software or Hosting Services; (x) introduce any virus or harmful code within the Hosting Services; (xi) remove, obscure or alter any copyright notices or name, logo, tagline or designation of Jama displayed on any display screen within Software (“Jama Marks”) or (xii) use the Software for production purposes.

**3. Proprietary Rights:** Jama owns the Software (including any updates or derivative works thereof) and the Jama Marks. Jama is granted a perpetual and irrevocable right to use any recommendations, suggestions, or other feedback provided by Evaluator pertaining to Software. If Evaluator elects to trial Jama Connect Advisor, Jama may monitor, collect, use, and aggregate any data Evaluator uses in connection with the Software for purposes of conducting analysis, including providing support, verification of security and data integrity, capacity planning, improving and developing Jama products and services, and benchmarking, provided that such data will only be disclosed to third parties in an anonymous form in a way that Evaluator cannot be identified from such data.

**4. Support:** Jama may during the Evaluation Period make available updates, enhancements, and/or modifications to the Software and may provide such updates to Evaluator, but is under

no obligation to do so. The provision by Jama to Evaluator of such updates, enhancements, and/or modifications to the Software shall be subject to all terms and conditions of this Agreement and shall expire at the end of the Evaluation Period.

**5. Specific Disclaimer of Warranty and Limitation of Liability:** THE SOFTWARE AND HOSTING SERVICES ARE PROVIDED WITHOUT WARRANTY OF ANY KIND. JAMA DISCLAIMS ALL WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE WARRANTIES OF MERCHANTABILITY, TITLE, NONINFRINGEMENT, AND FITNESS FOR A PARTICULAR PURPOSE. JAMA WILL NOT BE LIABLE FOR ANY DAMAGES ASSOCIATED WITH THE SOFTWARE OR HOSTING SERVICES, INCLUDING WITHOUT LIMITATION ORDINARY, INCIDENTAL, DIRECT, INDIRECT, OR CONSEQUENTIAL DAMAGES OF ANY KIND, INCLUDING BUT NOT LIMITED TO DAMAGES RELATING TO LOST DATA OR LOST PROFITS, EVEN IF JAMA HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT WILL JAMA’S LIABILITY UNDER THIS AGREEMENT EXCEED \$1,000.

**6. Termination:** Evaluator's license to use the Software and Hosting Services shall terminate on the earlier of (i) written notice by either Jama or Evaluator, or (ii) expiration of the Evaluation Period. Upon termination of the license as provided above, Evaluator shall promptly destroy the Software and any back-up copy of the Software made during the Evaluation Period. Evaluator shall also promptly return all materials provided by Jama in connection with the Software.

**7. Governing Law:** This Agreement shall be governed by the laws of Oregon, U.S.A. If either party employs attorneys to enforce any rights arising out of or relating to this Agreement, the prevailing party shall be entitled to recover reasonable attorney’s fees. The parties consent to the jurisdiction of the Oregon courts.

**8. Confidentiality.** "Confidential Information" shall be defined to include the Software, any software, source code, object code, documentation, test results, and any proprietary tools, proprietary knowledge or proprietary methodologies disclosed by Jama to Evaluator. Evaluator shall observe complete confidentiality with respect to the Confidential Information, and shall use its best efforts and take all reasonable steps to protect such from any use, reproduction, publication, disclosure, or distribution except as specifically authorized by this Agreement. Evaluator is solely responsible for any data Evaluator may upload into the Software during the Evaluation Period.

**9. Assignment:** This Agreement is not assignable or transferable by Evaluator and any attempt to do so is null and void.

**10. Entire Agreement:** This Agreement constitutes the entire agreement between the parties concerning Evaluator’s access and use of the Software and Hosting Services. This Agreement supersedes any prior verbal understanding between the parties and any Evaluator purchase order or other ordering document, regardless of whether such document is received by Jama before or after execution of this Agreement. This Agreement may be amended only in a writing signed by an authorized officer of Jama.
